To All and Singular the Sheriffs and Constables of this State, and Other Authorized Authorities -- Greetings:  
 YOU ARE HEREBY COMMANDED, that of the goods, wares, chattels, lands and tenements of the above you cause to be made by levy and sale the above sums of principal and interest and penalty and costs, together with future interest on the unpaid principal at the rate of one and one-half per centum (1 1/2%) per month, or fraction thereof, until paid, and additional penalty at the rate of .05% of total wages or Twenty (\$20.00) Dollars (whichever is greater) per month, or fraction thereof, missing wage reports are not filed, and all costs accruing by reason of the issuance of this fi. fa. and incident to levy and sale, all of which sums having accrued to this State and to the Unemployment Trust Fund established under authority of O.C.G.A. Section 34-8-83 of the Employment Security Law, and levied under authority of O.C.G.A. Section 34-8-167, this execution issued under authority of O.C.G.A. Section 34-8-167. (Prior to July 1, 1988, interest accrued at the rate of 1% per month; penalty accrued at the rate of \$10 per month. Prior to January 1, 1992, the percentage penalty did not apply.)

You are further commanded to have said several sums to be paid to the Commissioner of the Department of Labor of the State of Georgia, as administrator of the Employment Security Law, within sixty (60) days from this date. And have you then and there this writ. Herein fail not.
