 8 A No.
 9 Q Okay. And since you've -- have you
 10 continued to do any work for A. Vincent Pope PA at
 11 all?
 12 A That's my husband. I'm not sure what your
 13 question is.
 14 Q Have you done any remunerative work where
 15 you've received compensation for A. Vincent Pope PA
 16 in the past year?
 17 A I'm not sure I understand that question
 18 either.
 19 Q Okay. Have you done any work for
 20 A. Vincent Pope for which you have received
 21 compensation for your time in the last year?
 22 A I still don't understand the question.
 23 Q Have you been paid a salary or any wages by
 24 A. Vincent Pope?
 25 A No.

1 Q Okay. But you were previously paid a
 2 salary when you worked for A. Vincent Pope?
 3 A Yes.
 4 Q And that has been discontinued?
 5 A Yes.
 6 Q How many employees does Managing Partners
 7 have?
 8 A One.
 9 Q Just yourself?
 10 A Yes.
 11 Q You're presently married to Mr. Pope and
 12 you said you had two stepchildren --
 13 A Uh-huh.
 14 Q -- so I take it that this is not his first
 15 marriage?
 16 A That's correct.
 17 Q Does his former spouse live in DeKalb
 18 County?
 19 A No.
 20 Q Could you go ahead and at least tell me her
 21 name, just in case, for jury purposes?
 22 A Brenda Pope.
 23 Q Brenda Pope, okay. Since I've asked
 24 whether he's been previously married, have you been
 25 previously married?

1 A Yes.
 2 Q And when was that?
 3 A 1999.
 4 Q And your former spouse's name?
 5 A I'll spell it. S-u-l-a-y-m-a-n. Last name
 6 Clark with no E.
 7 Q Okay. And does Mr. Clark reside in DeKalb
 8 County?
 9 A No.
 10 Q Where does he reside?
 11 A I'm not positive.
 12 Q When were you divorced?
 13 A 2001.
 14 Q And then when did you marry Mr. Pope?
 15 A 2005.
 16 Q And was that divorce filed here in DeKalb
 17 County?
 18 A It was filed here in DeKalb County. There
 19 was a paperwork mixup, and I had to take my filing
 20 back, if that's what you're referring to, I had to
 21 take my filing back to show them that it was actually
 22 filed here and they had to resubmit, but yes, it was
 23 filed here in DeKalb County.
 24 Q So you got a final judgment and decree in
 25 2001?

 5 Q So you're telling me the clerk's office

 11 bankruptcy?
 12 A Yes.
 13 Q When was that?
 14 A '87, maybe.

 17 just moved from Illinois to Ohio.
 18 Q So this is when you moved to Toledo or
 19 Columbus?
 20 A Columbus.
 21 Q So do you recall whether you would have
 22 filed in the Middle District of Ohio?
 23 A I don't recall. I'm sorry.
 24 Q Okay. Have you ever testified in a
