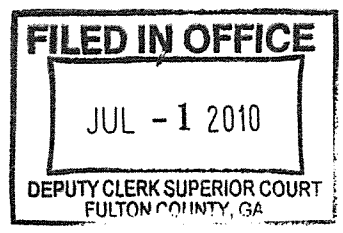

**FINAL ORDER**

This matter came before the Court on June 30, 2010, for an emergency hearing on Plaintiff Mary Norwood's Verified Complaint for Declaratory Judgment and Defendant Committee to Elect John Eaves, Inc.'s ("Eaves") Motion to Dismiss. At the hearing, the Court heard argument from Plaintiff Norwood, Defendant Eaves, and Defendant Fulton County Board of Registration and Elections. The Court finds that, at this time, there is no actual controversy, as required by O.C.G.A. § 9-4-2(a), and the ends of justice do not warrant a declaratory judgment, as required by O.C.G.A. § 9-4-2(b). Furthermore, the Court finds that to issue a declaratory judgment at this time would constitute an advisory opinion.

Accordingly, having considered the pleadings, motions, arguments, and the entire record, it is hereby ORDERED that Defendant Eaves' Motion to Dismiss is GRANTED, and Plaintiff's Verified Complaint for Declaratory Judgment is DISMISSED.

The Clerk is directed to CLOSE this case.
