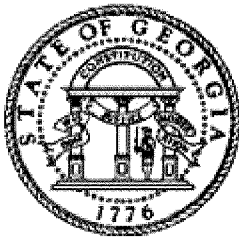
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION OF
FORECADDY, INC.

I.

The name of the corporation is: Forecaddy, Inc.

II.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The object of the corporation is pecuniary gain and profit and the corporation is formed for the following purposes:

To do business to such extent as a corporation organized under the Georgia Business Corporation Code may now or hereafter lawfully do, to do, either as principal or agent, and either alone or in connection with other corporations, firms, or individuals, all and everything necessary, suitable, convenient, or proper for, or in connection with or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designated directly or indirectly to promote the interest of this corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the Georgia Business Corporation Code or under any act amendatory thereof, supplemental thereto, or substituted therefor;

And to enter into any other lawful businesses from time to time, without limitation.



V.

The corporation shall have all of the powers and shall enjoy all of the rights, privileges and immunities as provided for under the Georgia Business Corporation Code.

VI.

The corporation shall have authority to issue 100,000 shares of common stock of no par value.

VII.

The corporation shall be entitled to purchase its own shares out of its unreserved and unrestricted earned and capital surplus available therefor.

VIII.

The corporation shall be entitled to distribute a portion of its assets to its shareholders out of capital surplus available therefor.

IX.

The corporation shall not commence business until it shall receive not less than \$500.00 in payment for the issuance of shares of stock.

XII.


