Section 34-8-83 of the Employment Security Law, and levied under authority of O.C.G.A. Section 34-8-167, this execution issued under authority of O.C.G.A. Section 34-8-167. (Prior to July 1, 1988, interest accrued at the rate of 1% per month; penalty accrued at the rate of \$10 per month. Prior to January 1, 1992, the percentage penalty did not apply.)

You are further commanded to have said several sums to be paid to the Commissioner of the Department of Labor of the State of Georgia, as administrator of the Employment Security Law, within sixty (60) days from this date. And have you then and there this writ. Herein fail not.
